## **Overview**

### **Certification Exam Committee**

Eden Energy Medicine Certification Exam Committee oversees the certification process for Eden Energy Medicine Certified Practitioners (EEM-CPs). It is responsible for making decisions regarding all aspects of the Certification Program such as eligibility standards; development, administration, and scoring of exams; and operational processes involved in the Certification of Eden Energy Medicine Certified Practitioner (EEM-CP) candidates.

### **Mission Statement for the Eden Energy Medicine Certification Exam Committee**

The Mission of the Committee is (1) to establish standards for Eden Energy Medicine Certification that validate the Practitioner's expertise and ability in the application of Eden Energy Medicine, and (2) to award the credential to qualified candidates. Certification ensures the public that holders of the Eden Energy Medicine Certified Practitioner credential are competent, responsive practitioners who enhance the quality and application of Eden Energy Medicine.

### **Importance of Certification**

An Eden Energy Medicine candidate who attains the credential of Eden Energy Medicine Certified Practitioner (EEM-CP) is dedicated to providing exceptional client care as well as her/his own self-care through a commitment to constant lifelong learning and maintenance of the Certification credential. The process of maintaining active status as an EEM-CP keeps practitioners and instructors current and engaged in the latest understanding and best practices within Eden Energy Medicine.

EEM Certification involves a rigorous process of study, testing, and evaluation that is designed and administered by experts in the area of Eden Energy Medicine.

### **Eligibility for Certification as an Eden Energy Medicine Certified Practitioner**

Certification as an Eden Energy Medicine Practitioner is open to all candidates who have satisfactorily graduated from the Eden Energy Medicine Level 2: Certification Training or who can demonstrate an equivalent education in Eden Energy Medicine.

## **Nondiscriminatory Policy\***

EEM endorses the principles of equal opportunity. Eligibility criteria for the Certification Exam are applied equally to all candidates regardless of race, religion, gender, national origin, sexual orientation, veteran status, age, marital status, or disability.

## **Quality Control**

- Advanced EEM-CPs and Faculty are carefully selected to support the Education Committee in various activities to help define the standards, update the assessment instruments as appropriate, and ensure that the Certification remains relevant to the profession.

## **Exam Information**

The official name of the exam is **The Eden Energy Medicine Certified Practitioner Exam**.

Exams are based on the knowledge, skills and tasks that a candidate has learned through the *Level 1: Fundamentals* and *Level 2: Certification Training* programs. The testing process includes four components: a written exam and a live demonstration focusing on the concepts and techniques of Eden Energy Medicine, and a written and oral exam focusing on ethical principles that are relevant to the practice of EEM. These components are detailed here:

### **1. Written Exam on the Concepts and Techniques of EEM**

- The exam contains a minimum of 100 multiple-choice questions covering content from Level 1: Fundamentals and Level 2: Certification Training.
- There is a 2-hour time limit for taking the exam. It typically takes candidates 1 to 1-1/2 hours to complete.
- You must get **90%** of the questions correct to successfully pass the exam.
- The candidate will automatically receive their numerical score from the online examination system within 30 minutes and will receive instructions on the next step if he or she did not pass.

### **2. Live Demonstration of EEM Techniques (approximately 1-1/2 hours to 2 hours).**

This component of the testing is done live, either in person or via video conference call (usually via Zoom) with a Qualified Examiner.

- The examiner will question the candidate on various elements and protocols contained within the Level 1: Fundamentals and Level 2: Certification Training.
- There is a 2-hour time limit for taking the exam. It typically takes candidates 1-1/2 hours to complete.

- You must get **75% (a minimum of 84 out of 112 possible points)** to successfully pass the exam.
  - There is a total of 28 elements. You will be scored on each element of the exam based on 4 categories:
    - Area of Concern - 1 point, Partial Mastery – 2 points, Mastery – 3 points, Exceeds – 4 points
  - To achieve a Mastery score you must demonstrate all elements of the question accurately as evaluated by the Qualified Examiner.
  - To achieve an Exceeds score on any element you must demonstrate all elements the question at an “experienced practitioner” level as evaluated by the Qualified Examiner.
  - In some instances where you have completed the majority of the demonstration to the satisfaction of the Qualified Examiner, but did not fully demonstrate all elements of the question, you will receive a Partial Mastery score.

### 3. **Written Ethics Exam:**

- The written Ethics Exam contains 48 multiple-choice questions covering content from the *Ethics Handbook for Energy Healing Practitioners* and the Ethics material covered in *Level 1: Fundamentals* and *Level 2: Certification Training* program.
- The multiple-choice exam is open-book and you are allowed **3** hours to complete the exam.
- The candidate must get **85% (a minimum of 41 out of 48)** of the questions correct to successfully pass the exam. Scores will generally be sent by e-mail within two business days after completing the exam. If a passing score was not obtained, feedback and instructions on the next step will be sent within 30 minutes.
- Re-taking the Ethics Written Exam is unlimited and free.
- The candidate must wait 48 hours before re-taking the Ethics Written Exam.

### 4. **Ethics Oral Exam (approximately 1 hour)**

- The Ethics Oral Exam is administered either in-person or via conference call (usually Zoom) by a Qualified Ethics Examiner.
- **The candidate must have passed the Written Ethics Exam before scheduling the Oral Ethics Exam.**
- The candidate must have the *Ethics Handbook for Energy Healing Practitioners* available during the Oral Ethics Exam.

- The exam will consist primarily of the Examiner presenting a scenario that an EEM practitioner may encounter and asking the candidate to identify the primary ethical issue involved, to identify the ethical principles designed to offer guidance in handling this type of situation (time will be allotted to refer to the *Ethics Handbook for Energy Healing Practitioners* to review the list of ethical principles), to identify dilemmas this particular scenario presents that go beyond the guidance available from the general ethical principles, and to describe how he or she might handle the situation.
- The Qualified Examiner will provide the pass/fail score and written feedback to the candidate within 48 hours of exam completion.

*\*We have timed and tested the exam to allow for a reasonable time for the majority of candidates to complete the exam. If you have a learning disability and/or require additional time to take the exam, please contact us at [certification@edenenergymedicine.com](mailto:certification@edenenergymedicine.com) to request a time exception. You must state your valid reason for requesting an exception to the testing policy.*

### **Exam Eligibility**

An individual who receives their Eden Energy Medicine Level 2: Certification Training diploma from an authorized Level 2: Certification Training Program is eligible to take the exam. Candidates cannot use the “EEM-CP” credential until they have successfully completed each component of the exam and must follow the [EEM-CP Continuing Training](#) guidelines and process to maintain their Certification.

### **Exam Security and Privacy Policy**

### **Copyrighted Examination Questions**

All exam questions are the copyrighted property of EEM. It is unlawful to copy, reproduce, record, distribute, or display these exam questions by any means, in whole or in part. Violations may be subject to civil and criminal penalties as well as loss of EEM-CP credentials.

## **Confidentiality and Non-Disclosure\*:**

Confidentiality is an important aspect of maintaining the integrity of the exam. We require every candidate to help in keeping the content of each component of the exam confidential. All of the exam questions are considered confidential. Candidates must agree to honor this confidentiality by signing the confidentiality agreement which is part of the application to take the exam. This confidentiality includes not discussing the questions or the exam with any other candidates or individuals. Violation of the exam confidentiality may have consequences up to being barred from earning or retaining the credential. The only exception is in discussing exam questions the candidate found challenging *on a consultation basis* with a current EEM Certified Practitioner or Faculty Member or in a formal study group with other candidates who also failed the exam.

## **Legalities**

Any of the following actions can result in the denial, suspension, or revocation of Certification with exam fees not refunded:

- Being abusive or otherwise uncooperative during the exam
- Substantial reason exists to believe the individual has received help or otherwise cheated during the exam
- Impersonating an exam candidate
- Reconstructing, reproducing, or transmitting any portion of exam materials, or receiving such materials
- Falsification of the Certification Application or any other requested material
- Misrepresentation of Certification Status
- Any circumstances that limit the EEM-CP's ability to function and perform the tasks normally associated with the practice of an EEM-CP

## **Taking the Exam**

Here are the steps to follow when preparing to take the exam.

### **Prepare for the Test**

This handbook contains the following:

- Background information about the exam, as well as the information and instructions for the exam.
- Test preparation guidelines to provide suggestions and help alleviate anxiety about taking the test.

- The syllabus of materials used in creating the test questions and a list of topics/protocols required for the live demonstration.
- A list of helpful resources to prepare for the exam.

### Registering to take the Exam

Eligible candidates will register to take the Certification Exam by going to <https://www.eemcentral.com> selecting the **Certification Exam Registration** tile activated on the candidates dashboard upon receiving their Level 2 diploma. You will be requested to register and pay the exam fee of \$450 prior to exams being given. You will be able to schedule your in-person demonstration sessions immediately upon registration, or if you are unable to commit to one of the dates and times listed on the scheduling form, you can return at a later time to schedule your sessions. Please allow up to 30 minutes for the system to process your registration and activate the exams.

### Registering to take the Exam

The following is an outline of the registration process for the exam.

- **Eligibility.** The candidate must meet the eligibility requirements to apply for the exam of either being a current **Level 2: Certification Training** graduate or having received an equivalency waiver from Innersource.
- **Qualified Examiner.** A list of Qualified Examiners and their available times will be included on the application form. Each Qualified Examiner has been trained and certified to provide the appropriate environment for the exam, as well as a computer with internet access for any remote testing components requested of the exam. If you elect to do your live demonstrations via video conference call, it is your responsibility to ensure you have the appropriate equipment and internet connection to successfully support the exam. Please review our [Exam Technology Requirements](#) article prior to requesting a remote exam.
- **Select Test Date.** The computer-based multiple-choice examinations will be available to you within 30 minutes of applying for the exam. The demonstration and oral component of the exam must be scheduled through the online scheduling form.
  - **EEM Written Exam**  
This is a timed test and candidates must complete it within the time specified (2 hours). A reasonable time to complete the exam is approximately 1 to 1 1/2 hours. The system will monitor the time you spend on the exam. The computer exam will terminate if you exceed the time allowed. The system will notify you when the exam time is completed on the written exam. Your exam will be graded upon completion by the system and you will automatically receive your score within 30 minutes. The system will let you know which questions you missed but does not provide you the correct answer.

- Before beginning, instructions for taking the exam will be provided on-screen.
  - The exam will have a minimum of 100 multiple-choice questions.
  - The questions are displayed one at a time with multiple answers and the candidate will indicate their choice.
  - The candidate can skip questions in order to return to them later if they choose.
  - When the test is completed, the candidate's responses are automatically recorded and graded.
  - Candidates will receive immediate notification within the system and an email notification within 30 minutes that confirms their score.
  - If a candidate does not receive a passing grade, the email will include instructions on how to re-take the exam, as well as feedback on which areas need improvement.
  - There is a re-take fee of \$75.00 for the EEM Written Exam.
  - There is a 48-hour waiting period on re-taking the EEM Written Exam.
  - Candidates are allowed to take the live EEM Demonstration before taking the EEM Written Exam if they choose.
- **EEM Live Demonstration**
    - If for any reason you must reschedule the EEM live exam, a 48-hour minimum notification is required, or a \$200 cancellation fee will apply.
    - Candidates are allowed to take the live EEM Demonstration before taking the EEM Written Exam if they choose.
    - This portion of the test is 2 hours (maximum).
    - Candidates are allowed to use study items from the list of Approved Exam Materials further below in this document.
    - The candidate will be expected to successfully score 84 out of 112 points on the exam to pass.
    - If a Candidate does not pass the EEM Live Demonstration, they will be allowed to re-take the test at a future date, but no sooner than three months (90 calendar days) after the unsuccessful attempt.
    - Candidates will receive written feedback about their score from their Examiner within 48 hours.

- **Ethics Written Exam**

This is a timed test and candidates must complete it within the time specified (3 hours). The system will monitor the time you spend on the exam. The computer exam will terminate if you exceed the time allowed. The system will notify you when the exam time is completed on the written exam. Your exam will be graded upon completion by the system and you will automatically receive your score within 30 minutes. The system will let you know which questions you missed but does not provide you the correct answer.

- Candidates are NOT allowed to take the Ethics Oral Exam before taking and passing the Ethics Written Exam.
- This is a timed test and candidates must complete it within the time specified (3 hours).
- The questions are displayed one at a time with multiple answers and the candidate will indicate their choice.
- The candidate can skip questions in order to return to them later if they choose.
- When the test is completed, the candidate's responses are automatically recorded and graded.
- Candidates will receive an immediate notification within EEM Central and an email notification within 30 minutes that confirms their score.
- If you do not receive a passing grade, the email will include instructions on how to re-take the exam, and you will receive feedback from the system when a question is missed on which areas to study.
- Re-taking the Ethics Written Exam is free.
- Candidates must wait 48 hours before re-taking the Ethics Written Exam.

- **Ethics Oral Exam**

- Candidates are NOT allowed to take the Ethics Oral Exam before taking and passing the Ethics Written Exam.
- If for any reason you must reschedule the Ethics oral exam, a 48-hour minimum notification is required, or a \$100 cancellation fee will apply.
- Maximum allowed time is 1 hour for this exam.
- To successfully pass the Ethics Oral Exam, the candidate must achieve a passing score from the Examiner.
- Candidates will be notified of their score within 48 hours of exam completion by the Examiner.
- Candidates are *required* to bring *The Ethics Handbook for Energy Healing Practitioners* to the Oral Exam. Please see list of other Approved Exam Materials further below in this document.

- **Submission of Application** Once you successfully completed your Level 2 Diploma, the certification registration will be added to your EEM Central Dashboard. To access EEM Central go to <https://www.eemcentral.com>. Registration information is on the last page in this document.
- **Confirmation of Receipt** of your application will be provided immediately upon registering via email. When you schedule your Examiner(s) as part of the live exams, your selected Examiner will receive your date and time selected. If for any reason you need to cancel or reschedule, please notify the Examiner within 48 hours of the scheduled session. Please ensure you provide valid contact information and your availability requested on the form.

### Select a Qualified Examiner and Testing Location

EEM uses a group of qualified and trained examiners for the live components of the Certification testing. You may either take the exam in-person at an agreed upon location of the Qualified Examiners choice, or you may elect to take the exam remotely through video conference following our exam **Technical Requirements** article located here: <https://edenmethod.com/technical-requirements/>.

This system allows candidates to take the exam with a variety of times and methods for flexibility.

### It is the candidate's responsibility to select a date, time and Qualified Examiner.

As part of the application process, it is your responsibility to select the date and time available from the Qualified Examiner schedule. There is no time limit on scheduling the exam once your application is approved, but you will not be able to successfully complete all of the exam components without scheduling the live demonstrations and oral elements of the exam. You may either schedule your live components upon submitting the application or you will be provided a link to schedule at a later time. All available examiners and their time slots, up to 60 days in advance, will be listed on the application form.

1. The multiple-choice written exams are administered by a computer over the internet and the following conditions are needed:
  - a. The candidate will receive e-mailed instructions including log-in links, information, and instructions for the test electronically from the Eden Energy Medicine Certification Staff.
  - b. **The test is being offered via your secure student account through Eden Energy Medicine Central (EEM Central).** You will access EEM Central through a web browser (Google Chrome recommended) on your computer and/or through the Matrix LMS app for iOS or Android mobile devices. You will see the introductory video located under the Navigating EEM Central section of

the article.

2. **Candidate Assurance Statement:** As part of the online application, the candidate will be required to digitally sign and accept the following statement:

*I understand and affirm that all exam questions are the copyrighted property of EEM. I affirm that I will not copy, reproduce, record, distribute, or display these exam questions by any means, in whole or in part. I understand that this confidentiality includes not discussing the questions or the exam with any other candidates or individuals. I affirm that I will maintain good conduct as outlined in the EEM Certification Exam Handbook. I understand that the score reported at the end of this exam represents the percentage of items answered correctly and does not indicate a pass or fail.*

## Identification

Candidate must show the examiner in person or on the Zoom screen one form of ID with their name, signature, and current photo as authorization to take the EEM Live Demonstration and the Ethics oral component of the exam.

Acceptable forms of photo ID include a current driver's license with photo, a current state ID card with photo, a current passport with photo, or a current military ID with photo.

## Examination Restrictions

- For a list of approved exam materials, please see the **Approved Exam Materials** list below. Use of a cellular phone or other electronic devices during the live EEM Live Skills Demonstration Exam and the Ethics Oral Exam is strictly prohibited and will result in dismissal from the exams.
- No questions concerning the answers to the content of the exam may be asked of the Qualified Examiner during the exam.
- You may take a break whenever you wish, but you will not be allowed additional time to make up for time lost during breaks.
- You are expected to not access personal items such as books, phones, notes, or non-approved handouts during the break.

## Multiple-Choice Test

The computer-based exam is a secure computer environment on EEM Central where the candidate will log in to start the exam.

For timed multiple-choice exams, you must complete them within the time specified. The questions are displayed one at a time with multiple answers and the candidate indicates their choice. The candidate can skip questions in order to return to them later, if they choose. When the test is completed, the candidate's responses are automatically recorded and graded.

## **Approved Exam Materials**

For the live EEM Live Skills Demonstration Exam the candidate may reference the following charts provided by Innersource when instructed by examiner:

- Neurolymphatic Points, Neurovascular Points, Sedating and Strengthening Acupressure Points, Source Points, Seed Points, Radiant Circuit Locations, Acupoint Locations on Spleen and Liver Meridians, Muscle Meridian Chart, Zone Tapping Chart, Revitalizing Electrics Protocol, Finger Modes, Wind Points, and Xi Cleft Points.
- Magnet (if you are not magnet-sensitive)
- Crystal
- Stainless steel spoon

For the EEM Written Exam the candidate may utilize:

- Blank notepad and/or paper for taking notes
- Pencil, pen, and/or eraser

For the Ethics Written and Oral components the candidate may utilize:

- All available book and video resources necessary to successfully complete the tests.
- Any notes or discussion points utilized in development of case study response for discussion with oral examiner.

## **Special Examination Accommodations**

EEM recognizes that at times a candidate may request special testing accommodations and will make every attempt to address a request for testing accommodations based upon review of documented health needs. In all cases, requests for special accommodations and documentation of special needs are required at the time of application submission.

## **Exam Results**

Multiple-Choice exam results will be reported immediately within the system and within 30 minutes upon completion of the exam via email with the percentage correct for each test. You will not be provided the correct answer for the questions missed. However, you will receive notification immediately with each question missed and the related class where that material is covered.

For your live and oral component results, you will be notified within 48 hours of the end of your session by the Qualified Examiner if you passed or failed the exam, as well as be an exam report of the areas where you need to improve.

## **Exam Appeals Policy**

The exam outcome is based upon a candidate achieving a passing score on the exam. If the candidate received a non-passing score and they believe there is an error in the system or would like to dispute the grade of the Qualified Examiner for their live components, they may request an appeal by clicking the appeals process link located at <https://edenmethod.com/taking-the-exam/> and completing the form at the bottom of the page and clicking submit. All appeals will be responded to within 48 hours. Investigations of the appeal, depending on the circumstance, may take up to 30 days.

## **Non-Passing Score on the Examination**

If a candidate does not pass certain components of the exam, they have the opportunity to re-take each test.

### **EEM Written Exam**

- If the candidate does not receive a passing grade on the EEM Written Exam, they may re-take the test for a fee of \$75 per exam.
- There is a 48-hour time limit on re-taking the EEM Written Exam.
- Each test is randomly generated so no two tests are alike.

### **Ethics Written Exam**

- If a candidate does not receive a passing grade on the Ethics Written Exam, they can re-take the Ethics Written Exam an unlimited number of times and there is no charge.
- Candidates must wait 48 hours before re-taking the Ethics Written Exam.

### **EEM Live Demonstration Exam**

- If a Candidate does not pass the EEM Live Demonstration, they will be allowed to re-take the test at a future date, but no sooner than three months (90 calendar days) after the unsuccessful attempt.
- If the candidate does not receive a passing grade on the EEM Live Demonstration Exam, they may re-take the test for a fee of \$300.
- All Zoom video conferencing sessions will be recorded for quality assurance.

### **Ethics Oral Exam**

- If a Candidate does not pass the Ethics Oral Exam, they will be allowed to re-take the test at a future date.
- The Candidate will be able to schedule the new session with an examiner once a minimum of 48 hours has passed after the unsuccessful attempt.
- If the candidate does not receive a passing grade on the Ethics Oral Exam, they may re-take the test for a fee of \$200.
- All Zoom video conferencing sessions will be recorded for quality assurance.

## **Cancellation of Scores**

EEM is responsible for the validity and integrity of the scores they report. On occasion, computer malfunction or misconduct by a candidate may cause a score to be suspect. EEM reserves the right to void or withhold exam results if, upon investigation, violations of its regulations are discovered. In the case of a suspect result due to malfunction of the system the candidate may reschedule another test with no additional charge, but the candidate is still responsible for any examination expenses.

## **Exam Score Retention**

Exam scores are retained by EEM for a minimum of five years. Successful completion of the Exam becomes permanent information on the EEM-CPs record.

## **Preparing for the Exam**

We all know how stressful it is to take tests and we would like to offer some strategies regarding how to prepare for the Eden Energy Medicine Certification Exam. First of all, please know that almost everyone has test anxiety and that a small amount of anxiety can actually assist you to perform better as you prepare to take the test. Many of you have studied energy work from a variety of perspectives. We strongly suggest that as you prepare for the exam, you utilize the recommended EEM resources as study guides. This will hopefully eliminate any confusion with questions that you might respond to differently based on your life's experiences. Good self-care will help you perform at your best.

### **Before taking test**

- Prepare for the test by reviewing this Handbook and being aware of the testing topics.
- Study the EEM syllabi and carefully review all components of each level of the EEM courses.
- Read and review the *Ethics Handbook for Energy Healing Practitioners* by David Feinstein prior to the exam.
- Make sure you are studying from recommended resources for the certification exam and that you respond to the test questions based on EEM's course of study.

### **The day of the test**

- Get a good night's sleep before the exam.
- Eat a healthy meal prior to taking the exam (best not to load up on carbs and perhaps get sleepy during the test!).

- Make sure you know where the test site is located, or if you have elected to do the test over video conferencing make sure you have the proper link and have gone through all the technical tests and requirements listed here <https://edenmethod.com/technical-requirements/> and get to the location or join the conference call in plenty of time so you can remain relaxed.
- Go to the test well prepared (you have studied for the test, you are comfortably dressed, you might even use an essential oil to help diminish any feelings of stress and anxiety).

### **What to Bring**

In addition to a client, please bring a magnet (if you are not magnet-sensitive), a crystal, and a stainless-steel spoon to your demonstration session.

During the demonstration, you will be allowed to look up anything that one might expect to look up during a regular Eden Energy Medicine (EEM) session by bringing the following illustrations or charts with you to your session:

- Sedating and Strengthening Acupressure Points
- NL and NV Points
- Source Points
- Seed Points
- Radiant Circuit Locations
- Acupoint Locations on Spleen and Liver Meridians
- Muscle Meridian Chart
- Zone Tapping Chart
- Revitalizing Electrics Protocol
- Finger Modes
- Wind Points
- Xi Cleft Points

The test is intended to be comprehensive and will also include material that you are expected to know **without** reference to a chart. For example, you should know the locations of the Alarm Points and meridian pathways, as well as the information contained in the 24-hour Flow Wheel and the Five Rhythms model. During the demonstration session, you will be required to demonstrate competency in this basic level of material without referring to a book or chart.

## **During the test**

- Take a centering breath before you begin – take time to mentally prepare and focus on the task at hand before reading that first question.
- Read each question twice before answering – make sure you understand what the question is asking. Think of your own response before you look at the response choices on the test.
- Promote your self-confidence before and during the test by using positive self-talk.
